_____ **AUTOMATIC DELIVERY** Oil is automatically delivered to your home, payment must be received by E. F. Winslow within 10 days of delivery. There is no charge for this program, customer is charged market price for the oil, and must leave a credit card on file with our office.

_____ **FLEXIBLE CAPPED PRICE AUTOMATIC DELIVERY** Oil is automatically delivered to your home, payment must be received within 10 days of delivery. Before September 15, 2006 Customer is locked in at the guaranteed rate of \$2.689/per gallon from October 15, 2006- April 30, 2007. After September 15, 2006, Customer is locked in at the guaranteed rate of \$2.739/per gallon from October 15, 2006 - April 30, 2007. **If the market price of oil drops, customer will receive the lower rate.** Customer must send in a \$100 deposit, and a non-refundable \$59 lock in fee along with this signed contract. The \$100 deposit will be applied toward your April 2007 delivery. ** (The \$159 will be non-refundable if you withdraw from this contract on or before April 30,2007)

_____ **PREPAID AUTOMATIC DELIVERY** Oil is automatically delivered to your home. Before September 15, 2006 customer receives E.F. Winslow's lowest rate of \$2.669. After September 15, 2006 the rate will be raised to \$2.689 Customer prepays for the number of gallons desired (800 gallon minimum/1200 gallon maximum; one delivery address per contract). Last oil delivery must occur on or before April 30, 2007. There is a \$159 early withdrawal fee, if you withdraw from this contract on or before April 30, 2007.
